4. Public Forum

- Mary Foley calls Council's attention to the poor upkeep on First Ave. between Poplar and Geneva alongside the railroad tracks. She is a long-time resident of Clinton Ave. and speaks as well for her neighbors. The bushes need to be trimmed; there are random piles of railroad ties and garbage lying around. The residents have notified the city on numerous occasions and were given many different and conflicting responses, but nothing has ever been done. She urges the City to work with the Union Pacific Railroad to clean this area up. It is required by City ordinance.
- Joe Suto is a neighbor in the area; he has lived there 31 years. The area used to be kept up well, but since around 2000 the oversight has not been done and 'things have gone to the dogs'.
- Jay Webb, President of York H.S. Alumni Association. He invites Council members and the public to the week-long Centennial celebration. He stresses that this is

a city-wide affair, not just for the High School. He lists out all of the events planned for the entire week. He specifically asks the Mayor to attend, and asks the entire community to give their support by attending the many events that are planned.

- John Quigley, Chair of the Elmhurst Chamber of Commerce, is here to formally promote the Elmhurst-Opoly board game; they ordered 1000 games, 300 have already been sold. Thanks to the City government for its support.
- Karen Allen has lived in the 100 block of Clinton Ave. for 18 years and agrees with what has already been said. She emphasizes the sound-buffering role of trees along the railroad tracks. The noise routinely gets up to 105 decibels which can damage hearing; 85 decibels is the agreed limit for avoiding noise-induced hearing loss. She requests that if clean up requires taking down the existing trees, new trees be planted.
