Steven M. Morley, Mayor

- Julia Nittie is a resident of the Elmhurst 255 development, has recurrent issues with parking for her guests. Currently they cannot park for more than 3 hours without calling the Police Dept. and obtaining an overnight permit, which are limited to 5 per year. She asks the City to work with her and her fellow residents to set up a better system going forward.
- Eileen Oser, a resident of Fremont St., explains the controversy between Elmhurst Extended Care and the neighbors. There have been unfounded accusations of vandalism and other intimidating actions by the EEC owners related to the re-opening of hearings on their zoning waiver request, which was turned down a year ago based on many neighborhood concerns. She asks that the City make sure that the process of considering zoning waivers is polite and professional and not subject to wild accusations on either side.
- Claude Pagasz expresses his opinions about the budgeting process and wishes everyone a safe and happy Thanksgiving.
- Barbara Lonergan presents a detailed critique of the OHare Fly Quiet program. She encourages our Council representatives on ONCC to recruit new suburban towns to the ONCC especially those from South and SW suburbs. She hopes the City will address the ONCC's flawed decision making process because it is not equitable, decisions are taken with out a documented process, and votes are too rushed. She points out that the City's current involvement with the ONCC was the direct result of residents' input. Now please consider joining FAIR.

7. Reports and Recommendations of Appointed and Elected Officials

- Mayor Morley reminds everyone that after the close of this meeting the Council will continue their review of the 2018 budget.
 - He announces that another \$2.4 million for the Metra station remodeling was awarded last week, in addition to the \$10 million pledged a month ago. The total cost for the renovation is \$17 million so the project is well on its way.
 - He announces that IC Catholic defeated Wilmington and Byron HS and will face Pleasant Plains on Friday in DeKalb. We wish them success.
 - The 34th annual Dan Gibbons Turkey Trot will take place on Thursday.
- City Manager Grabowski wishes everyone a safe and enjoyable Thanksgiving from City staff. He introduces Mr. Dave Oldburg, the new director of the Elmhurst History Museum. Mr. Oldburg speaks briefly; he has been on the job 4 days and looks forward to working with staff and the Board in planning upcoming exhibits.
- Ald Dunn reviews the latest from the ONCC: The least favorable option for the Fly Quiet runway rotation was adopted by the Ad Hoc committee last week; this is very disappointing. The suggested flight paths will impact Elmhurst every other week. Elmhurst presented a better option but it was treated as a token and was not even fully discussed. The full ONCC will vote on the unfavorable option on December 8 and Ald. Dunn expects that it will be passed. He remains hopeful that other affected communities will continue to pressure ONCC so that a better alternative can be implemented.
- Ald Polomsky reports on a presentation the Public Safety Committee had last week from Metropolitan Family Services.
 MFS serves mostly elders and their caregivers. In the last year they have assisted 488 Elmhurst residents. Please contact them if you need services.
- Ald. Bram also comments on the Ad Hoc ONCC committee meeting this past Friday. He was greatly disappointed with the unfair decision-making process that was followed. Community input, data and survey results were ignored. He encourages all residents and City officials to come out to rally against the plan on December 8.
