- * a. Gateway Bd. met last week, reviewed contract for services; next meeting they will review the officers
- * b. Sugar Creek Golf Course: the first meeting since Nov. 2016 took place on 2/28; they reviewed endof-year status. There were 12 fewer playable days with a small deficit compared with 2015, but in view of this the course's financial condition is very good. The good weather this past February resulted in twice as many golf rounds as Feb. 2015. Junior golf registration is up, as are reservations for banquets. The course itself is in great shape compared to most early springtimes because of the mild winter.

9. BOARD BUSINESS

- a. Unfinished Business (Old):
- * 1) Plunkett Park Playground Redevelopment Project Bid for \$122,513 to Hacienda Landscaping; \$18,310 for drinking fountains, fence; play equipment for \$163,576. Staff explain the process of bidding, reference checking, etc. Construction is planned for August 15 October.
 - approved 7 0.
- * 2) Plunkett Park Playground Soft Surfacing Bid of \$62,307 to Perfect Turf, Inc. Staff and Dir. Rogers explains why there was only one bid received and the staff process of due diligence.
 - approved 7 0.
- * 3) Tobacco Ban on All Park District Property was reviewed by Policy Committee. They present EPD's current policy of no smoking within 20 feet of concessions, ball fields, playgrounds, etc; staff also presents information from other venues in Illinois & nationally. Staff explain their decision-making process and the implications of going tobacco-free. Dir. Rogers asks for Board approval only to go forward to solidifying the plan, not for adopting the policy tonight. Comm. Kies summarizes the Committee discussion; a full board discussion follows. Sugar Creek Golf Course would not be included in the ban, but Wilder Park and Mansion would be under the ban. Comm. Spaeth emphasizes the need to call it a ban on tobacco (of all types) not just smoking.
 - approval to go ahead toward implementing the tobacco ban is granted 7 0.

b. New Business:

* 1) Credit Card Processing Merchant Services Agreement – Staff explains the selection of a vendor to process credit card payments; the need to change vendor because the current one, Plug-n-pay, promised to have their chip processing ability in place ~18 mo ago but they haven't yet done it. The switch to Card-Connect will be at no additional cost to PD. Board discussion follows.
