 - Overall revenue is up from 2016 third quarter by 0.8%
 - Overall Expenses are up 1.3% from 2016 due to the land acquisitions this year.
 - Targeted to hit this year's budget.
 - The Park District was over budget by 36% of where they should be this year, but the property acquisitions were unplanned. The budget would have allowed for the properties to be bought if the opportunity had come about around the time of making the budget.
 - If you take out the properties that were bought, they would be about 1% within of what the budget was planned for.
