A. Draft Operational Plan 2017-2020 This was the same presentation that was given to the Board at their retreat last Thursday. (See previous observer report for Special Board meeting 7/13/17.) There was also a:

- Report on Summer School at Conrad Fischer where Principal Jane Bailey, an instructional coach and teacher Jami Gabelman presented. They spoke about the summer school that was held, in which a multi-age group of 1<sup>st</sup> and 2<sup>nd</sup> graders spent half their morning studying space and the other half studying architecture.
- An interdisciplinary forum at York Principal Erin DeLuga and English chair Kevin Poduska described the two interdisciplinary forums that were conducted at York last year: One on Justice, Liberty and Social Focus and the other on Erin's law (sexual abuse awareness – mandated by law). York plans on developing a forum for each grade level every quarter this upcoming year. These develop student's critical thinking in literacy, writing and research skills.
- A brief comment about communications: "The District is securing the services of a communications consultant to help determine the extent to which the community would consider supporting facility upgrades and what it would prioritize as a part of any long term plan to enhance District facilities and protect the investment of existing and future homeowners. Ultimately, any potential long term plan will reflect the additional input that is part of Phase II of the Focus 205 Community Engagement Process."
