register, October 7, 2008, at our local libraries and throughout our community. Although we already have a strong core of ready, willing and able registrars, we anticipate another record turnout during the registration drive, as the upcoming election has many people excited and eager to make their voices heard at the polls.

LWVIL Student Election Activities

Illinois Student Vote

This program offers teachers and students the opportunity to participate fully in the electoral process. Participating schools and classes will undertake activities to study the candidates and issues of the 2008 election. They will then be able to make informed decisions as they vote for candidates in a simulated election.

LWVIL has received a grant from the McCormick Foundation to fund this year's Illinois Student Vote. Jesse White, Illinois' Secretary of State, also is a sponsor. A web site, www.illinoisstudentvote.org has free downloadable curriculum for K – 12 grade, space for teachers to post pictures, videos, and more curricula ideas. All Illinois schools have received a brochure in April and will receive another in August. **We need your help getting the word out. Please encourage any teachers you know to participate!**

High School Simulated Federal Election

LWVIL has also received a grant from the U. S. Elections Assistance Commission for a simulated federal elections program for high school students held before the November 4, 2008, presidential election. The DuPage County Election Commission and 12 high schools in DuPage County have committed to doing this mock election with actual election equipment! All five DuPage County Leagues will be asked to help run these mock elections that will take place between mid September and mid October. Please call Jan Dörner to volunteer to help with this activity. The 12 DuPage high schools that will be participating are: York, Westmont, West Chicago, Wheaton Warrenville South, Wheaton North, Naperville North, all four Glenbards (North, South, East, West), Fenton and Downers Grove South. At the moment, we are in the planning phase of this project and as more information becomes available, it will be passed on!

National Program for the 2008-2010 Biennium Delegates voted at the Monday Plenary session to adopt the recommended Program with the following addition to the Principles: **The LWVUS believes that all powers of the US government should be exercised within the constitutional framework of a balance among the three branches of government: legislative, executive, and judicial.**

Massachusetts Healthcare Reform: Miracle or Mirage? After consideration of the provisions and inadequacies of the MA 2006 "Chapter 58" healthcare law and its resulting problems, it is apparent that this reform is a mirage. This program has not enabled an "equitable distribution of healthcare services" throughout the state. Instead, the state's existing costly and complex private/public programs were left intact and supplemented with an additional layer of public/private plans allocated by income level.

Healthcare Reform: Strategy for the Future State and national efforts are needed now to help people understand the issues. State programs need mechanisms for transfer of funds. National publicly funded, privately delivered healthcare would save money for city and county governments. Small businesses cannot afford to provide healthcare to employees; their margins are not big enough. Healthcare costs must be based on their actual cost not on what is billed, which has a poor correlation with cost. Several state leagues shared their experiences as they are currently pursuing efforts for healthcare reform.

Health Care Program: At the Monday Plenary session, the delegates voted to **adopt a Health Care program to educate members and communities in order to be better prepared to do health care advocacy as needed.**

Climate Change This was one of the hottest topics at convention this year and on Monday,

the delegates voted to adopt **A Multi-Level Education and Advocacy Campaign to promote solutions to global climate change.** The LWVUS Climate Change Task Force has been in place for the past year and a half and has produced quite a bit of material available to for local Leagues to use. The task force is preparing a FAQ on coal and has information on emissions cap and trade schemes and carbon taxes to curb global warming.

Protect Our Great Lakes (ILO) The Lakes have been threatened by export and diversion schemes, including refilling the Ogallala aquifer and shipping Lake water to Asia and to the southwest US. These schemes were blocked by an agreement between eight states and two Canadian provinces. Other threats include pesticides, past and present industrial pollution, raw sewage overflows, toxic sediments, invasive species, and wetland loss. The 2001 Great Lakes Legacy Act is now up for reauthorization and would triple funding to expand eligible projects beyond just cleanup to restoring aquatic habitat, funding public information and education programs, eliminating bureaucratic red tape that limited the effectiveness of the original Legacy Act, and encouraging development of innovative technology to permanently destroy contaminated sediments. The United Nations in 2008 An annual wrap-up is available on the website. Women of all ages are the concern of the NGO Commission the Status of Women. This group has launched a campaign on Violence Against Women. Visit www.saynotoviolence.org to sign a petition and to get more information. Identity documentation is an important issue. Identity is a human right; however, many people cannot prove who they are because they have no document. Births may not be registered or records may be destroyed during disasters.

Public Financing Campaign Reform Public financing campaign reform takes big private money out of political campaigns and gives citizens a meaningful role in candidate selection. It increases competition, reduces special interest group influence, and allows candidates with public support rather than private money donors to run for office. Various state Leagues shared their experiences advocating for public financing reform measures.

Diversity: My Community, My League No matter where they are located, all Leagues do work that impacts diverse communities, whether it is intended or not, and can use this as a starting point for outreach. Diversity goes beyond race, gender, or culture; Leagues can develop strategies to be “intentionally generational” and

culturally competent when reaching out to diverse groups.

Election Integrity This caucus was held to discuss the rationale for and exact wording of a resolution to adopt specific criteria to be used when advocating for election integrity measures. While the resolution failed to pass in the Monday plenary session, the caucus did raise some very interesting issues, including the potential for conflict of interest between LWV Voter Service (where many of our members work hard to cultivate good working relationships with local election officials) and our advocacy efforts for fair, transparent elections, often viewed with suspicion by those same election officials.
