## **Student/Staff Recognition:**

## **Superintendent's Communications:**

A. Technology Funding FY14: Technology Director David Smith, presented the 2013-15 technology roadmap. The proposed expenditures for technology for 2013-14 are \$2.675 million and for 2014-15 is \$3 million. The target percentages are 50% maintenance (warranties and contracts), 36.5% enhancement (replacements) and 13.5% for transformational technology.

Computers and devices have increased to over 4600 this year from 1800 in FY07. The technology support staff has not increased and is not proposed to increase.

The drivers of this tech plan are:

- Increase student access to devices.
- Digital curriculum development.
- Principal leadership and training.
- More teacher professional development.
- Significant investments in the District infrastructure.
- Improvements in technology staff.

<u>B. FY 14 Budget:</u> The administration was asked to restructure the District's finances to come up with a 5-year plan to come up with a sustainable model. Superintendent Pruneau stated that the administrative team was meeting regularly to come up with this plan.

## **Board Committee Reports:**

A. Mrs. Stuefen reported on the **Board Improvement/Policy Committee.** The committee reviewed a draft of a budget presentation to be used for presentation to the public. They also decided to use the District Leadership Team (DLT) to bring up their follow-up questions on the Harris Poll for the teachers. Another set of questions will be developed for parents.

B. Mrs. Ebner discussed the **Curriculum and Instruction Committee** meeting. They discussed York High School's new instructional materials, goals and plans of the committee (to be continued over the summer), and the curriculum review cycle. The curriculum review cycle is comprehensive and should be linked to the finances.
